






OPPORTUNITIES TO SHARE KEEP GROWING

"Faster, simpler, more secure data sharing where information is treated as a corporate asset"





By 2025, IDC estimates there to be **175 zettabytes of data in the world** (a number equal to as many 'bytes' as there are grains of sand on all the world's beaches x 175)¹

BETTER RESIDENT SERVICES

Data sharing means more advanced analytics, a better understanding of resident needs, and enhanced decision-making





INCREASED EFFICIENCY

Clearer, simpler data sharing processes reduce duplication of effort and administrative work for staff – freeing up their time to focus on what matters



IMPROVED RISK MANAGEMENT

When staff understand the rules, they're more likely to make sure data is kept secure when required, reducing the risk of breaches, potential errors



Which methods do you use to share data? Select all that apply.







SHARING SECURELY




- **Data:** Corporate Asset






Governance


A data sharing standard supporting York Region's existing policy framework, and clear roles and responsibilities, will set the tone for the organizations data sharing and clarify expectations of staff.

Tools

A toolkit providing a decision tree, agreement templates and approved sharing platforms will streamline data sharing processes.

Training

Training resources will ensure staff have the skills and knowledge required to share data effectively and foster a culture where data sharing is valued.

Specific Questions




- Who is the recipient?

Clear Guidance




- Who should you consult

DATA SHARING TOOLS & RESOURCES

Accepted Tools and Platforms

A comprehensive list of tools and platforms accepted for sharing data, including guidance on when and how to use them, ensures staff can share effectively and securely.

Data Agreement Templates

Data agreement templates with guidance on use help staff get started with new data sharing partners while creating consistency across the organization.

"Preparing to speak with..."

FAQs and project outline templates help staff prepare for conversations with Legal or Privacy to save time and ensure best outcomes for everyone.

WHAT WE LEARNED



Make it matter to them:

 Staff need simple and actionable guidance and easy to use technology that is relevant to their day-to-day work.


Be agile:

 We didn't get everything perfect the first time. By applying the framework on small projects and inviting discussion, guidance can be continually adapted and improved.

With a change in dialogue comes a change in culture

COMMON OBSTACLES TO INTERNAL AND EXTERNAL SHARING



- Lack of formal data governance (process/ technology)
- Use restrictions privacy
- Data misuse and misinterpretation liability
- Time and resources incentives
- Data costs/budget (proprietary data and data collection)

- Custom data acquisitions: strength in numbers


DATA PRODUCTS ARE ALSO DATA SHARING
